Kaurna Smoking Ceremony and Project Launch marks start of construction

A major milestone in the delivery of the AACC project was reached on 14 December, as construction commenced at Lot Fourteen.

At the official Project Launch, the commencement of construction was celebrated by Senior Kaurna custodians, leaders and elders, as well as project stakeholders.

AACC looks to the future with new Kaurna name

The AACC's Kaurna name was also unveiled at the Project Launch, announced by Kaurna Elder Uncle Jeffrey Newchurch.

The Centre will now be known as Tarrkarri, (pronounced tar-ka-ri) – Centre for First Nations Cultures.

The new name means 'the future' in Kaurna language and symbolises the setting of strong foundations for the Centre, located on the Adelaide Plains.

The naming process was overseen by the AACC Aboriginal Reference Group and given cultural consent by Kaurna Warra Karrpanthi.

Design and Construction Update

The AACC Project Ambassador and Aboriginal Reference Group continue to provide input into the design process, guidance on cultural protocols and long-term operations and governance of the AACC.

The Early Works Tender closed on 19 November 2021 and the contract is expected to be awarded by early December 2021.

Negotiations with the preferred Tenderer for the Managing Contractor for construction is now completed and expected to be awarded by the end of November 2021. Design development activities are in progress and the team is seeking to establish working groups with subject matter experts to inform the next level of detailed design.

The tailored Industry Participation Plan has been finalised by the Office of the Industry Advocate (OIA) with Department for Infrastructure and Transport (DIT), addressing Aboriginal Economic Participation Strategy requirements.

AACC Receives Planning Approval

The Aboriginal Art and Cultures Centre received planning approval last week, via the State Commission Assessment Panel, who approved the plan as recommended, with no changes.

The feedback from the panel was highly complimentary, based on the quality of the design and the planning application itself.

The panel found the proposal to be an "interesting and innovative design" that interfaced well with North Terrace and responded positively to its setting between the Park Lands, university campuses and the CBD. "The overall development is compatible

with the topography of the land and the built form interfaces well with the soft and hard landscaping surrounding the building – providing a seamless connection to the public realm," the assessment report stated.

An <u>ArchitectureAU</u> article showcased further artist impressions of the Centre with commentary and positive feedback from stakeholders alongside further detail on how the Centre will interface with the surrounding area.

Design and Construction Update

Design development activities are continuing, and the project team is growing with Samantha Wilson joining as Aboriginal Economic Participation Officer role and Pusheela Jummun as Principal Project Manager. Both start in November. Recruitment is currently also underway for a Communications and Marketing Officer.

The Early Works Tender period is planned to commence in late October, with the Public Works Committee approval granted.

The preferred Tenderer for the Managing Contractor for construction has been selected and is in final negotiations.

Design and Construction Update

The Development Plan Application has been submitted and Planning Approval process is underway, aiming for a State Commission Assessment Panel hearing by end of October.

The Public Works Committee Hearing at Parliament House was held on 23 September 2021. The Committee has endorsed the commencement of public works on the AACC.

The team are currently in the tender process for a Managing Contractor, aiming to appoint by end of October/early November with early works commencement by the end of the year.

AACC Recruitment

And, lastly, recruitment is in full progress to fill key roles in the AACC project team including; Principal Project Manager, Aboriginal Economic Participation Officer and a Communications Officer.

New designs released

Plans for the Aboriginal Art and Cultures Centre (AACC) have now entered the state's planning approval process, after being submitted to the State Commission Assessment Panel this month.

The Aboriginal Reference Group has provided strategic direction and leadership to ensure the establishment of the Centre is in line with cultural expectations and represents Aboriginal cultural history and truth-telling.

Compared to designs released earlier this year, there is significantly more detail with regards to landscaping and external areas, with the introduction of an outdoor amphitheatre and event space.

The planning application will go on public exhibition for a period of three weeks from the end of August.

In the meantime, the Department for Infrastructure and Transport is working with Aboriginal businesses to ensure they are ready to tender for work to deliver the project from November 2021.

Release of the AACC Aboriginal Economic Participation Strategy

The AACC Aboriginal Economic Participation Strategy outlines how the once-in-ageneration Aboriginal Art and Cultures Centre project has the opportunity to be an exemplar for creating opportunities for Aboriginal

economic participation through partnerships and collaboration.

Historically, Aboriginal people have been excluded from opportunities to share the nation's wealth.

In the contemporary era, the development of a robust and sustainable 'Aboriginal economy' is essential for realising selfdetermining futures, facilitating sustainable and independent communities, and closing the gap.

It is in this context that the Australian and South Australian Governments (along with other jurisdictions) have implemented policies and programs to encourage and support new Aboriginal businesses.

The AACC has an opportunity to assist in driving the change in social standards for Aboriginal people and communities of South Australia. There are opportunities for Aboriginal economic participation from both an employment and procurement perspective across all phases of the AACC project.

While the majority of initiatives can commence within the following twelve months, there are three distinct phases that the initiatives will impact. These are:

Pre-construction: opportunities are focussed on the architectural design and interior design of the AACC. This phase commenced in 2020 and there has been a focus on Aboriginal employment opportunities with the design lead contractor.

Approximate timeline - 2021

Construction opportunities for Aboriginal economic participation will be centred around the building of the AACC itself. This phase has direct employment and procurement targets through the Adelaide City Deal and a

significant portion of initiatives within the Strategy focus on achieving these targets through the development of the Aboriginal business sector to support the build and creating an Aboriginal talent pool to become part of the supply chain workforce.

Approximate timeline - 2022 to 2024

Ongoing operations: of the AACC will create long term sustainable opportunities for both Aboriginal employment within the centre and Aboriginal businesses either directly by supporting the operations or indirectly through tourism opportunities beyond the centre in Adelaide and regionally.

Approximate timeline - 2025 onwards

At the workshop attendees considered the detail around the Flexible Theatre, Outdoor Amphitheatre, Green Room, General Outdoors and Façade.

Other considerations suggested included:

- Restaurant menu to be inspired by Australian native food
- Accessibility for Elders to be considered for across the whole site
- Internal performance space requires a maintenance/workshop area (consider this in Back of House)
- Consideration to change the admin space to a workshop for theatre
- Essential void space possibility to suspend artwork and allow for works of scale
- Possibilities for AACC to host festivals such as Spirit Festival, Melbourne Fashion, Survival Day etc
- Provide flexibility for intimate functions and large grand functions
- Lot Fourteen integration so that AACC is part of broader environment
- Create retreat rooms to facilitate safe and quiet spaces to accommodate any visitor responses and cultural protocol requirements
- Explore having a smoking cleansing of the building and all spaces before the opening

Aboriginal Economic Participation Strategy to be released

Overseen by the AACC Aboriginal Reference Group, the AACC Aboriginal Economic Participation Strategy has been developed for the purpose of defining opportunities and practical solutions to support the realisation of economic benefits for Aboriginal people throughout the construction and ongoing operations of the AACC.

The AACC Aboriginal Reference Group will continue to oversee the implementation of *the Strategy* through regular monitoring and evaluation.

Aboriginal business briefing

Aboriginal businesses will be invited for a briefing on the AACC project on 15 July 2021 at Tandanya.

We will hold an informal briefing session exclusively for Aboriginal owned businesses to discuss the Aboriginal Economic and Workforce involvement during the project.

Maximising opportunities for local Aboriginal owned businesses and Aboriginal workforce participation are key priorities for the project.

Involving businesses early in the process means we will be able to build relationships and optimise participation and benefits from the project.

Infrastructure SA Gate 3 Review

The project has completed Infrastructure SA Gate 3 (Procurement) review, enabling the project to proceed to appoint a Managing Contractor through a two-stage procurement, including the Registration of Interest (ROI) and Request for Tender (RFT). The ROIs were issued to the qualified builders through the Department for Infrastructure and Transport (DIT) on 13 May 2021 with a closing date of 10 June 2021. Industry briefing sessions will be held with the qualified builders, Aboriginal businesses and non-Aboriginal businesses, starting with the Tier 1 suppliers on 25 May 2021.

Aboriginal Economic Participation Strategy for AACC Project

PwC Indigenous Consulting are currently developing an Aboriginal Economic

Participation Strategy which will define the opportunities for Aboriginal engagement. The Strategy will also identify initiatives to ensure sustainable Aboriginal procurement and employment are embedded into the operation of the AACC.

The Adelaide City Deal Implementation Plan aims to achieve a minimum Aboriginal employment level of 1.4% and 3% of contract value expenditure with Aboriginal businesses.

Aligned with the State participation policy a target of 2% of Aboriginal employment participation has been set for the AACC.

A number of consultation sessions have been held across government and industry to explore gaps and identify the existing programs and initiatives that can support the implementation of the strategy.

The draft strategy will be completed by end-April for review by the AACC Aboriginal





Reference Group and the State and Federal Government agencies.

Aligned with the intent of the Strategy, the Lot Fourteen project team is in the process of recruiting an Aboriginal trainee to work on the AACC project.

Recruitment for an Assistant Director, Program & Strategy

Recruitment for an Assistant Director, Program & Strategy, AACC (curator) is underway with interviews to be held later in May 2021.

This role will work closely with the design team to inform the development of a cultural vision and the functional brief for the facility.

Design and Construction Development

The Department for Infrastructure and Transport (DIT) has been formally engaged to deliver the AACC project on behalf of the Department of the Premier and Cabinet.

DIT has engaged architects Woods Bagot (working in partnership with Diller Scofidio + Renfro) as the Lead Professional Services Contractor.

The current program assumes a 12-month design period and a 30-month construction period, with opening in early 2025.

DIT has recommended that the project be delivered under a Managing Contractor procurement model and is currently finalising the procurement documentation.

The Registration of Interest for the building contractor is scheduled to be released to the market in May 2021 followed by the Request for Tender.
